## THE CLEARVIEW LEARNING MODELS

CLEARVIEW LOCAL SCHOOLS WILL OFFER TWO OPTIONS FOR THE 2020-2021 REOPENING PLAN.

**GOAL:** TO PROVIDE A QUALITY EDUCATION FOR OUR STUDENTS DURING THE COVID-19 PANDEMIC WHILE PROVIDING A SAFE AND SECURE ENVIRONMENT FOR OUR STUDENTS AND STAFF.

**NOTE:** THIS PLAN IS FLUID AND CAN CHANGE AS THE COVID-19 PANDEMIC CHANGES. ADDITIONAL INFORMATION WILL BE COMMUNICATED AS UPDATES BECOME AVAILABLE.

#### OPTION #1

- 1. HYBRID/REMOTE MODEL: STUDENTS WILL BE ON AN A/B SCHEDULE.
- STUDENTS IN GROUP <u>A</u> WILL PHYSICALLY ATTEND CLASSES ON MONDAY AND TUESDAY. WEDNESDAY, THURSDAY, AND FRIDAY WILL BE REMOTE LEARNING DAYS.
- STUDENTS IN GROUP **B** WILL PHYSICALLY ATTEND CLASSES ON THURSDAY AND FRIDAY. MONDAY, TUESDAY, AND WEDNESDAY WILL BE REMOTE LEARNING DAYS.
- GROUP A = LAST NAMES (A-L) GROUP B = LAST NAMES (M-Z)
- ADMINISTRATION WILL CONTACT YOU IF THEY NEED TO MAKE CHANGES FOR THE SAFETY OF ALL. PLEASE DO NOT CALL TO REQUEST CHANGES.
- TEACHERS WILL HAVE LESSONS AND/OR ONLINE INSTRUCTION ON THE REMOTE LEARNING DAYS.
- TEACHERS WILL BE ON CAMPUS EVERY DAY IF THERE IS A NEED TO CONTACT THEM. EMAIL IS THE BEST FORMAT TO USE WHEN CONTACTING STAFF MEMBERS.
- NO STUDENTS WILL BE IN THE BUILDINGS ON WEDNESDAYS.
- CLEARVIEW TEACHERS, K-12, WILL BE UTILIZING GOOGLE CLASSROOM AS THE ONLY PORTAL FOR INSTRUCTION AND COMMUNICATION. ALL CLS
   STUDENTS HAVE ACCESS TO A GOOGLE CLASSROOM ACCOUNT

## **OPTION #2**

## 2. VIRTUAL/E-LEARNING MODEL:

- THIS OPTION IS FOR OUR CLEARVIEW FAMILIES WHO ARE NOT COMFORTABLE SENDING THEIR CHILDREN TO SCHOOL DURING THE COVID-19 PANDEMIC. THOSE FAMILIES WHO CHOOSE THIS OPTION WILL HAVE TO COMMIT TO A FULL SEMESTER OF ONLINE COURSEWORK. FAMILIES COMMITTING TO THIS PLAN WILL NOT BE IN THE BUILDING AT ALL DURING THE 1<sup>ST</sup> SEMESTER OF THE 2020-2021 SCHOOL YEAR. A COMMITMENT FORM MUST BE SIGNED AND ON FILE IN OUR OFFICES. ONCE YOU COMMIT, YOU WILL NOT BE ABLE TO RETURN TO IN-SCHOOL CLASSES DURING THAT SEMESTER. THE REGISTRATION PERIOD FOR THE FIRST SEMESTER WILL BE JULY 24TH- AUGUST 7TH.
- STUDENTS IN GRADES K-5 WILL ENGAGE IN THE CALVERT ONLINE LEARNING PLATFORM. <u>HTTPS://CALVERTLEARNING.COM/</u>

#### LEVEL SYSTEM—OHIO PUBLIC HEALTH ADVISORY SYSTEM

THE SAFETY OF OUR STUDENTS AND STAFF IS A HIGH PRIORITY FOR THE CLEARVIEW LOCAL SCHOOLS DISTRICT. THEREFORE, OUR REOPENING PLANS AND HOW WE PROCEED THROUGHOUT THE SCHOOL YEAR WILL RELY HEAVILY ON THE OHIO'S PUBLIC HEALTH ADVISORY SYSTEM, ALONG WITH OUR COUNTY HEALTH DEPARTMENT, THE OHIO DEPARTMENT OF EDUCATION, AND ANY DIRECTIVES ISSUED BY THE GOVERNOR OF OHIO. THERE ARE FOUR (4) LEVELS ISSUED BY THE STATE. EACH HAS ITS OWN RATING REGARDING THE SPREAD OF COVID-19. THE LEVELS ARE AS FOLLOWS

- LEVEL 1 (YELLOW)—ACTIVE EXPOSURE AND SPREAD. CLEARVIEW LOCAL SCHOOLS WILL PROVIDE INSTRUCTION AS DESIGNATED IN THE REOPENING PLAN WHILE MAINTAINING PUBLIC HEALTH AND SANITATION MEASURES. (HYBRID/REMOTE MODEL)
- LEVEL 2 (ORANGE)—INCREASED EXPOSURE AND SPREAD. EXERCISE A HIGH DEGREE OF CAUTION. CLEARVIEW LOCAL SCHOOLS WILL PROVIDE INSTRUCTION AS DESIGNATED IN THE REOPENING PLAN WHILE MAINTAINING PUBLIC HEALTH AND SANITATION MEASURES. (HYBRID/REMOTE MODEL)
- LEVEL 3 (RED)—VERY HIGH EXPOSURE AND SPREAD- LIMIT ACTIVITIES AS MUCH AS POSSIBLE. CLEARVIEW LOCAL SCHOOLS WILL PROVIDE INSTRUCTION AS DESIGNATED IN THE REOPENING PLAN WHILE MAINTAINING PUBLIC HEALTH AND SANITATION MEASURES. (HYBRID/REMOTE MODEL)
- LEVEL 4 (PURPLE)—SEVERE EXPOSURE AND SPREAD. ONLY LEAVE HOME FOR SUPPLIES AND SERVICES. CLEARVIEW LOCAL SCHOOLS WILL TRANSITION TO A COMPLETE REMOTE LEARNING ENVIRONMENT DURING THIS TIME PERIOD. THERE WILL BE NO FACE TO FACE INSTRUCTION PROVIDED DURING THIS TIME.

## LEVEL SYSTEM—OHIO PUBLIC HEALTH ADVISORY SYSTEM (CONTINUED)

- THE ABOVE MENTIONED LEVELS WILL DETERMINE HOW LEARNING WILL TAKE PLACE. KEEP IN MIND THAT LEVEL 4 CAN CHANGE FROM WEEK TO WEEK, SO BE PREPARED TO TRANSITION AT ANY GIVEN TIME. COMMUNICATION WILL GO OUT IF WE ARE ENTERING OR LEAVING A LEVEL 4 SITUATION. ALSO, KEEP IN MIND THAT A LEVEL 4 COULD TAKE PLACE BEFORE THE FIRST DAY OF SCHOOL, SO BE PREPARED TO MAKE THAT ADJUSTMENT, AS WELL.
- GIVEN THE UNPREDICTABILITY OF COVID-19, CONTINUED CORONAVIRUS SPIKES MAY IMPACT OUR REOPENING PLAN THUS IT WILL REQUIRE THE DISTRICT TO MODIFY THE CURRENT PLAN. BASED ON PUBLIC HEALTH GUIDANCE, SCHOOL CLOSURES MAY BE ORDERED AND THE DISTRICT WILL IMPLEMENT A COMPLETE REMOTE LEARNING PLAN. PLEASE BE PREPARED AND PLAN AHEAD IN THE EVENT THE DISTRICT MUST CHANGE PLANS WITH SHORT NOTICE. NOTE: THOSE STUDENTS WHO ELECT TO USE THE VIRTUAL/E-LEARNING PLATFORMS WILL REMAIN WITH THOSE PROGRAMS. THOSE WHO HAVE ELECTED TO ATTEND CLASSES VIA THE HYBRID MODEL WILL ENGAGE IN COMPLETE REMOTE LEARNING WHEREBY THE TEACHERS WILL CONTINUE TO TEACH YOU REMOTELY. ATTENDANCE WILL BE TRACKED.

## **IMPORTANT DATES AND REMINDERS**

THE CALENDAR DATES FOR THE 2020-2021 SCHOOL YEAR HAVE BEEN SET.

- THE 1<sup>ST</sup> DAY OF SCHOOL FOR STUDENTS IN GRADES 1-12 WILL BE AUGUST 24TH. THIS IS A CHANGE FROM OUR ORIGINAL START DATE. THE LATER START DATE FOR STUDENTS ALLOWS FOR ADDITIONAL STAFF TRAINING AND PROFESSIONAL DEVELOPMENT SO THAT THEY CAN PREPARE FOR REOPENING.
- KINDERGARTEN START DATES ARE AS FOLLOWS: AUGUST 27TH (<sup>1</sup>/<sub>2</sub> GROUP), AUGUST (<sup>1</sup>/<sub>2</sub> GROUP). THE WEEK OF AUGUST 31ST WILL BE REGULAR HYBRID DAYS FOR ALL KINDERGARTEN STUDENTS.
- OPEN HOUSE, ORIENTATIONS, AND CONFERENCES WILL LOOK DIFFERENTLY THIS YEAR. EACH BUILDING WILL CONTACT YOU AS TO HOW THOSE WILL TAKE PLACE. IF YOU HAVE QUESTIONS, PLEASE CONTACT YOUR CHILD'S SCHOOL BUILDING.
- PROFESSIONAL DEVELOPMENT DAYS FOR STAFF WILL REMAIN THE SAME. THEREFORE, STUDENTS WILL NOT ATTEND SCHOOL ON DAYS THAT HAVE BEEN PRE-DESIGNATED
   AS PROFESSIONAL DEVELOPMENT DAYS.
- REMINDER: NON- SCHOOL DAYS FOR STUDENTS DURING THE 1<sup>ST</sup> SEMESTER

- ATTENDANCE—ATTENDANCE WILL BE TAKEN IN ALL CLASSES. PLEASE READ THE ATTENDANCE RULES THAT ARE IN THE STUDENT HANDBOOKS.
- GRADES—CLASSWORK WILL BE GRADED AS NORMAL AND CREDIT WILL BE GRANTED. YOUR GRADES WILL BE REFLECTED ON YOUR ASSIGNMENTS. GRADES WILL ALSO BE
   REFLECTED IN POWERSCHOOL AND ON REPORT CARDS.
- TECHNOLOGY—FAMILIES WILL NEED INTERNET SERVICES FOR STUDENTS TO COMPLETE ONLINE ASSIGNMENTS. STUDENTS WILL NEED ACCESS TO ELECTRONIC DEVICES. (LAPTOP, DESKTOP, CHROMEBOOK, SMARTPHONE, ETC.).

# HYBRID/REMOTE LEARNING VS. VIRTUAL/E-LEARNING

IT IS IMPORTANT TO UNDERSTAND THE DIFFERENCE BETWEEN HYBRID/REMOTE LEARNING AND VIRTUAL/E-LEARNING AS YOU BEGIN TO MAKE PLANS ABOUT YOUR CHILD'S SCHOOLING FOR THIS UPCOMING YEAR.

## **HYBRID/REMOTE LEARNING**

HYBRID/REMOTE LEARNING—STUDENTS WILL HAVE IN-PERSON CLASSES AND SHIFT TO ONLINE LEARNING

- COVID-19 MAY SUDDENLY SHIFT AN INDIVIDUAL STUDENT, A CLASS, A GRADE LEVEL, A SCHOOL BUILDING, OR THE ENTIRE DISTRICT TO REMOTE LEARNING AT ANY GIVEN TIME DUE TO A QUARANTINE OR CLOSURE.
- SUBSTITUTES WILL BE AT A PREMIUM. THEREFORE, A SHIFT COULD ALSO BE CAUSED BY TEACHER AND STAFF COVID-19 ABSENTEEISM INCREASES AND SUBSTITUTES NOT BEING AVAILABLE.

## VIRTUAL/E-LEARNING

VIRTUAL/E-LEARNING—STUDENTS WILL ENGAGE IN COMPLETE ONLINE LEARNING 100% OF THE TIME. STUDENTS WILL ALWAYS REMAIN VIRTUAL. THE ASSIGNMENTS WILL NOT BE THE SAME AS THOSE WHO ATTEND IN-PERSON CLASSES. ATTENDANCE WILL BE TRACKED.

## **HEALTH AND SAFETY**

#### THERE IS NO WAY TO BE COMPLETELY SAFE. THERE IS NO SUCH THING AS ZERO RISKS, BUT WE HAVE INSTITUTED SEVERAL PROTOCOLS.

- HAND SANITIZER WILL BE IN EVERY CLASSROOM/COMMON AREA.
- MASKS OR FACE SHIELDS MUST BE WORN KINDERGARTEN-12<sup>TH</sup> GRADE.
- MASKS OR FACE SHIELDS MUST BE WORN ON THE BUSSES.
- MASKS OR FACE SHIELDS MUST BE WORN BY STAFF.
- PARENTS ARE EXPECTED TO CONDUCT DAILY HEALTH CHECKS OF THEIR CHILDREN PRIOR TO SENDING THEM TO SCHOOL, INCLUDING TEMPERATURE CHECKS.
- STAFF WILL VIGILANTLY ASSESS FOR SYMPTOMS.
- WASH HANDS WITH SOAP AND WATER FREQUENTLY FOR AT LEAST 20 SECONDS.
- SCHOOLS WILL BE THOROUGHLY CLEANED AND SANITIZED TO LIMIT THE SPREAD OF COVID-19.
- VISITORS WILL BE LIMITED. HOWEVER, ANY VISITOR, PARENT, OR GUARDIAN THAT ENTERS THE BUILDING WILL BE REQUIRED TO WEAR A MASK OR FACE SHIELD COVERING.
- PLEASE, PLEASE, PLEASE UPDATE YOUR CONTACT INFORMATION AND MAKE SURE THAT THE SCHOOLS HAVE YOUR CURRENT INFORMATION ON FILE. ALSO, MAKE SURE TO INFORM YOUR EMERGENCY CONTACTS THAT THEY ARE LISTED ON FILE.
- STUDENTS ARE ENCOURAGED TO HAVE THEIR OWN PERSONAL BOTTLE OF HAND SANITIZER.
- STUDENTS ARE ENCOURAGED TO BRING IN WATER BOTTLES. THEY CAN BE REFILLED AT THE HYDRATION STATIONS LOCATED IN EACH BUILDING. WATER FOUNTAINS WILL BE TURNED OFF.
- STUDENTS WILL NOT HAVE LOCKERS TO USE. THEREFORE, HAVING A BACKPACK WILL BE ESSENTIAL.
- STUDENTS WILL BE LIMITED WITH THEIR TRAVEL FROM CLASS TO CLASS IN THE UPPER GRADES. WHENEVER POSSIBLE, THE TEACHER WILL TRAVEL TO THE CLASSROOM AND
  THE STUDENT WILL REMAIN IN THAT CLASSROOM.
- IMPORTANT: STUDENTS WHO CONTINUOUSLY VIOLATE THE SAFETY PROTOCOLS WILL BE <u>DISCIPLINED AND MAY BE PLACED INTO THE VIRTUAL E-LEARNING</u> <u>PROGRAM</u>.

## **CONFIRMED CASES**

THE LORAIN COUNTY HEALTH DEPARTMENT WILL COMMUNICATE WITH INDIVIDUALS WHO ARE CONFIRMED COVID-19 CASES, SCHOOL LEADERS, AND ANY CLOSE CONTACTS WHO ARE IDENTIFIED. CLOSE CONTACTS ARE USUALLY THOSE INDIVIDUALS WHO HAVE SPENT MORE THAN 10 MINUTES IN CLOSE PROXIMITY (I.E., WITHIN 6 FEET OF THE INDIVIDUAL). THE HEALTH DEPARTMENT WILL IMPLEMENT CONTACT TRACING AND DETERMINE WHO IS CONSIDERED A CLOSE CONTACT OF THE PERSON.

COMMUNICATION WILL COME FROM THE HEALTH DEPARTMENT FOR USE BY THE SCHOOL. A LETTER TEMPLATE WILL BE DEVELOPED AND SENT OUT.

ANYONE TESTING POSITIVE FOR COVID-19 WILL BE ISOLATED, MONITORED DAILY, AND RELEASED BY THE HEALTH DEPARTMENT.

A 14-DAY QUARANTINE WILL BE REQUIRED OF ANY STUDENT OR STAFF MEMBER CONSIDERED TO BE A CLOSE CONTACT AS DETERMINED BY THE LORAIN COUNTY HEALTH DEPARTMENT.

## SYMPTOMS AT SCHOOL

IF A STUDENT OR STAFF MEMBER BEGINS TO SHOW SYMPTOMS OR HAS A TEMPERATURE ABOVE 100° F WHILE AT SCHOOL, THEY SHOULD IMMEDIATELY SEPARATE FROM OTHER STUDENTS AND STAFF MEMBERS IN A SEPARATE ROOM. THEY WILL THEN BE MONITORED AND CHECKED BY OUR SCHOOL NURSE AND SENT HOME.

IF SICKNESS IS NOT COVID-19 RELATED, THE INDIVIDUAL MAY NOT RETURN TO SCHOOL UNTIL THEY ARE FEVER FREE FOR 48 HOURS WITHOUT THE USE OF FEVER REDUCING MEDICATION. IF SICK PERSONS HAD CONTACT WITH SOMEONE CONFIRMED, OR ARE CONFIRMED, OR ARE PROBABLE TO HAVE COVID-19, THEY MUST COMPLETE ISOLATION OR QUARANTINE PROCEDURES IN COORDINATION WITH THE LORAIN COUNTY HEALTH DEPARTMENT PRIOR TO RETURNING TO CLEARVIEW LOCAL SCHOOLS.

## TRANSPORTATION

STUDENTS WILL BE REQUIRED TO WEAR A MASK OR FACE SHIELD WHILE ON THE BUS.

STUDENTS WILL HAVE AN ASSIGNED SEAT ON THE BUS.

FIELD TRIPS REQUIRING SCHOOL TRANSPORTATION WILL NOT BE SCHEDULED AT THIS TIME UNTIL FURTHER NOTICE.

STUDENTS WILL SIT 2 TO A SEAT ON THE BUS. PARENTS WHO ARE UNCOMFORTABLE WITH THIS OPTION CAN TRANSPORT STUDENTS IN THEIR PERSONAL VEHICLES.

BUSSES WILL BE SUPPLIED WITH HAND SANITIZER.

ALL BUS RULES AND REGULATIONS WILL BE ENFORCED. THOSE WHO DO NOT COMPLY MAY BE SUSPENDED FROM THE BUS AND PARENTS WILL HAVE TO TRANSPORT.

## **BUILDING ENTRANCES/EXITS**

EACH BUILDING WILL DESIGNATE DOOR ENTRANCES AND EXITS. THIS IS BEING DONE TO REDUCE CROSS TRAFFIC AND TO MAINTAIN PHYSICAL DISTANCING AS MUCH AS POSSIBLE.

SIGNS WILL INDICATE WHICH DOORS ARE AVAILABLE FOR ENTRANCE/EXIT. THIS INFORMATION WILL BE COMMUNICATED BY THE BUILDING ADMINISTRATION.

STUDENTS AND PARENTS ARE ASKED NOT TO CONGREGATE AT THE BUILDING ENTRANCES/EXITS BEFORE AND/OR AFTER SCHOOL.

IN ORDER TO FACILITATE STUDENT SUPERVISION, EFFICIENT BUS USE, AND LOGISTICAL DISTANCING, STAGGERED ENTERING AND EXITING THE BUILDING WILL BE IMPLEMENTED. THIS INFORMATION WILL BE COMMUNICATED BY THE BUILDING ADMINISTRATION.

## **ATHLETICS/BAND/CHOIR**

MORE INFORMATION TO COME REGARDING PERFORMANCES AND ATHLETIC EVENTS BEING HELD BOTH HOME AND AWAY. THE ATHLETIC DIRECTOR, BAND TEACHER, AND CHOIR TEACHER WILL COMMUNICATE FURTHER INFORMATION TO THOSE PARENTS AFFECTED.

## <u>REOPENING FAQ'S</u> FREQUENTLY ASKED QUESTIONS

- IF I CHOOSE THE VIRTUAL/E-LEARNING OPTION CAN I OPT OUT MID- SEMESTER? NO. YOU MUST COMMIT FOR THE ENTIRE SEMESTER IF YOU CHOOSE THE VIRTUAL PROGRAM. HOWEVER, YOU MAY CHOOSE TO COME BACK TO THE BUILDING FOR THE SECOND SEMESTER.
- WHEN IS THE FIRST DAY OF SCHOOL? THOUGH THE SCHOOL CALENDAR REMAINS THE SAME, THE FIRST DAY OF SCHOOL HAS BEEN PUSHED BACK FOR STUDENTS. THE STUDENTS IN GRADES 1-12 WILL BEGIN SCHOOL ON AUGUST 24TH. KINDERGARTEN STUDENTS WILL BEGIN ON AUGUST 27TH AND 28TH.
- HOW WILL REMOTE LEARNING BE DIFFERENT FROM THE SPRING? TEACHERS WERE THROWN INTO SOMETHING THEY WERE NOT USED TO DOING IN MARCH. HOWEVER, THEY TOOK WHAT THEY HAD AND FOUND CREATIVE WAYS TO CONTINUE TO CONNECT WITH STUDENTS WITH VERY LITTLE NOTICE. ALL REMOTE LEARNING THIS FALL WILL BE MORE ROBUST. LESSONS WILL INCLUDE HOMEWORK, TESTS, AND STUDENT GRADES THAT WILL REFLECT WORK COMPLETED AND NOT COMPLETED. STUDENTS WILL BE ACCOUNTABLE FOR WORK NOT COMPLETED AND THIS WILL BE REFLECTED IN THEIR GRADES. ATTENDANCE WILL BE TAKEN BY TEACHERS.
- CAN MY CHILD CONTINUE TO PARTICIPATE IN EXTRACURRICULAR ACTIVITIES? ABSOLUTELY. THE SAME CONSIDERATIONS ARE IN EFFECT. THEREFORE, STUDENTS MUST MAINTAIN PROPER GRADES TO PARTICIPATE IN ATHLETICS. SOME EXTRACURRICULAR ACTIVITIES MAY BE LIMITED OR ELIMINATED DUE TO COVID-19.
- IF I CHOOSE THE VIRTUAL/E-LEARNING OPPORTUNITY, WHAT WILL THAT LOOK LIKE FOR STUDENTS RECEIVING SPECIAL EDUCATION SERVICES? SERVICES IN A STUDENT'S IEP WILL CONTINUE TO BE ADDRESSED THROUGH ONLINE LEARNING. IF A PARENT CHOOSES 100% VIRTUAL LEARNING, PLEASE BE AWARE THAT SERVICES MAY LOOK DIFFERENT THAN IN THE TRADITIONAL SETTING. THE IEP TEAM WILL MEET TO DISCUSS WHAT SERVICES WILL LOOK LIKE IN THE ALTERNATE SETTING AND MAKE AMENDMENTS TO THE IEP THAT REFLECT THOSE SERVICES. STUDENTS WILL BE ASSIGNED A CASE MANAGER TO COORDINATE AND MONITOR SERVICES AND PROGRESS WHILE COMMUNICATING WITH PARENTS REGULARLY.
- IF THE OHIO PUBLIC HEALTH ADVISORY SYSTEM REACHES A LEVEL 4 (PURPLE), WILL SCHOOLS CLOSE? CLEARVIEW LOCAL SCHOOLS WILL TRANSITION TO A COMPLETE REMOTE LEARNING ENVIRONMENT DURING THIS TIME PERIOD. THERE WILL BE NO FACE TO FACE INSTRUCTION PROVIDED DURING THIS TIME.
- WILL TEMPORARY QUARANTINE AFFECT SIBLINGS OF THE EXPOSED CHILD IN THE SAME SCHOOL OR DIFFERENT SCHOOLS? IF A STUDENT TESTS
  POSITIVE, THEIR SIBLINGS WILL BE EXPECTED TO QUARANTINE AT HOME ACCORDING TO THE MOST CURRENT ODH GUIDELINES. IF A STUDENT IS
  QUARANTINED BECAUSE THEY ARE A CLASSROOM CONTACT OF SOMEONE WHO TESTS POSITIVE, THIS WILL NOT IMPACT THEIR SIBLINGS.

# REOPENING FAQ'S FREQUENTLY ASKED QUESTIONS

- WHAT ABOUT STUDENTS WHO CANNOT WEAR MASKS BECAUSE OF MEDICAL ISSUES? ANY STUDENT WHO HAS DIFFICULTY BREATHING OR CANNOT WEAR A MASK, MUST HAVE DOCUMENTATION FROM A HEALTHCARE PROVIDER INDICATING THEY CANNOT WEAR A MASK. IN SUCH A CASE, THAT CHILD WILL BE ASKED TO WEAR A FACE SHIELD. ANY CHILD WHO IS INCAPACITATED OR OTHERWISE UNABLE TO REMOVE THE FACE COVERING WITHOUT ASSISTANCE WILL NOT BE REQUIRED TO WEAR A MASK, BUT, THEY TOO, MUST WEAR A FACE SHIELD. ADDITIONALLY, STUDENTS WHO HAVE A REASON PURSUANT TO A 504 PLAN OR IEP TO NOT WEAR FACE COVERINGS WILL BE EVALUATED ON AN INDIVIDUAL BASIS TO DETERMINE WHETHER THERE ARE ADDITIONAL ACCOMMODATIONS THAT MAY BE MADE TO PROVIDE THEM AND OTHERS WITH THE GREATEST POSSIBLE PROTECTION.
- DO I HAVE TO PROVIDE MY OWN MASKS OR FACE SHIELDS? YES. PLEASE TEACH YOUR CHILD THE PROPER WAY TO WEAR THEIR MASK OR FACE SHIELD. THEY MUST ENTER THE BUILDING WEARING IT. PEDIATRICIANS ARE RECOMMENDING STUDENTS TO START WEARING MASKS AT HOME IN SHORT INCREMENTS SO THAT THEY ARE USED TO WEARING THEM PRIOR TO THE START OF SCHOOL.
- WILL THERE BE RECESS? YES. IT IS IMPORTANT THAT STUDENTS HAVE TIME TO UNWIND. THEREFORE, RECESS WILL BE RECONFIGURED TO PROVIDE AS MUCH SOCIAL DISTANCING AS POSSIBLE. EQUIPMENT WILL ALSO BE DISINFECTED.
- WILL STUDENTS BE ABLE TO BRING WATER BOTTLES? YES. WATER FOUNTAINS WILL BE SHUT DOWN. HOWEVER, THE HYDRATION STATIONS WILL REMAIN ON SO STUDENTS CAN REFILL THEIR WATER BOTTLES, IF NECESSARY. WATER BOTTLES MUST BE CLEAR.
- WHAT ABOUT VISITORS? VISITORS WILL BE LIMITED. PROTOCOLS WILL FOCUS ONLY ON THOSE THAT ARE EMERGENCY OR ESSENTIAL SITUATIONS.
   PARENTS WHO NEED TO BRING ITEMS TO SCHOOL OR PICK UP THEIR CHILD MAY HAVE TO WAIT IN THE VESTIBULE AREA AND MUST WEAR A MASK OR FACE SHIELD TO ENTER THAT AREA.
- WHAT ABOUT LUNCH? LUNCH WILL STILL BE PROVIDED TO STUDENTS ON A DAILY BASIS. THE FORMAT FOR THE LUNCH DISTRIBUTION DURING REMOTE DAYS WILL BE ANNOUNCED SOON.
- WILL THE SCHOOL BE THOROUGHLY CLEANED? THE BUILDINGS AND CLASSROOMS WILL BE CLEANED THROUGHOUT THE DAY AND EVERY NIGHT. WEDNESDAY'S WILL CONSIST OF MORE DEEP CLEANING.

# CLEARVIEW LOCAL SCHOOLS VIRTUAL LEARNING/E-LEARNING AGREEMENT

I HEREBY ACKNOWLEDGE, AFFIRM AND AGREE TO THE FOLLOWING:

- DUE TO THE COVID-19 CONCERNS AND RISKS POSED TO THE MEMBERS OF THE COMMUNITY WITH VULNERABLE HEALTH CONDITIONS, THE CLEARVIEW LOCAL SCHOOLS PERMIT PARENTS/GUARDIANS TO ELECT TO HAVE THEIR CHILD/CHILDREN PARTICIPATE IN AN ALTERNATIVE TO IN-PERSON INSTRUCTION FOR THE 2020-2021 SCHOOL YEAR. CLEARVIEW LOCAL SCHOOLS HAS ELECTED TO OFFER A FULLTIME VIRTUAL/E-LEARNING OPTION FOR OUR STUDENTS TO MEET THE NEEDS OF FAMILIES THAT ARE UNABLE OR UNWILLING TO SEND THEIR CHILDREN TO SCHOOL FOR IN-PERSON INSTRUCTION DUE TO COVID-19 RELATED CONCERNS.
- THIS LEARNING OPTION IS BEING OFFERED ON A TEMPORARY BASIS DUE TO THE CURRENT PUBLIC HEALTH EMERGENCY. THE CLS DISTRICT RETAINS THE RIGHT TO DISCONTINUE THIS PROGRAM IN ITS SOLE DISCRETION UPON AT LEAST ONE-WEEKS' NOTICE TO PARTICIPATING FAMILIES.
- THE CHOICE FOR VIRTUAL/E-LEARNING WILL BE BASED ON A SEMESTER BY SEMESTER BASIS. THIS AGREEMENT IS FOR THE FIRST SEMESTER OF THE 2020-2021 SCHOOL YEAR. STUDENTS ARE SUBJECT TO RETURN SECOND SEMESTER BASED ON UPDATED INFORMATION RECEIVED REGARDING THE STATUS OF THE COVID-19 PANDEMIC. STUDENTS WHO ELECT TO PARTICIPATE IN THIS OPTION MUST REMAIN IN THE PROGRAM FOR A FULL SEMESTER ONCE COMMITTED TO ENROLLMENT.
- TRADITIONAL LETTER GRADES ARE EARNED IN EACH COURSE AND TRANSFERRED ONTO THE CLS TRANSCRIPT/REPORT CARD USING THE SAME GRADING
   SCALE AS CLS.
- THE EXACT MATERIALS, TEXTS, AND ORDER OF PACING MAY VARY BETWEEN THE ONLINE AND IN-PERSON PROGRAMS.
- THE ONLINE VIRTUAL/E-LEARNING PROGRAM IS AVAILABLE FOR ALL STUDENTS IN GRADES K-12. WITH THIS PROGRAM, STUDENTS STAY ENROLLED WITH THE CLS DISTRICT AND ARE ALLOWED TO PARTICIPATE IN EXTRACURRICULAR ACTIVITIES.
- STUDENTS WITH IEP'S/504'S INTERESTED IN ENROLLING WILL NEED TO MEET WITH THEIR SCHOOL'S IEP/504 TEAM FIRST TO DETERMINE THE APPROPRIATENESS OF THE SPECIALLY DESIGNED INSTRUCTION.
- THE STUDENT SHOULD BE PROVIDED WITH A QUIET PLACE TO COMPLETE HIS/HER WORK. PARENTS SHOULD CHECK THAT THEIR CHILDREN ARE COMPLETING SCHOOL WORK DAILY. PARENTS SHOULD ALSO MONITOR ASSIGNMENTS AND PROGRESS TO ENSURE THEIR CHILD STAYS ON TASK AND ON TRACK.
