# Our Framework to Operate

**Symptom Checks:** A symptoms check should be conducted AT HOME, prior to riding the bus or leaving to attend school.

**Distancing:** Every effort will be made to keep distancing to six feet when possible. If not possible, students will be following facial covering protocols.

**Face coverings:** There will be mandatory face coverings for staff and students while on the bus and in school buildings in all grade levels. Students will not be able to enter the building without a face covering.

**Hand washing and hand sanitizer:** Regular hand washing will take place and hand sanitizer will be readily available to staff and students.

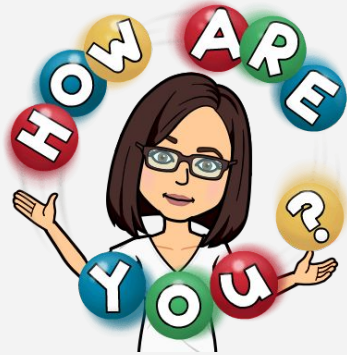
**Limiting movement throughout the buildings:** Although we know that children need time to move throughout their day, some scheduling adjustments will be implemented to limit movement when possible (ie: specials and restrooms).

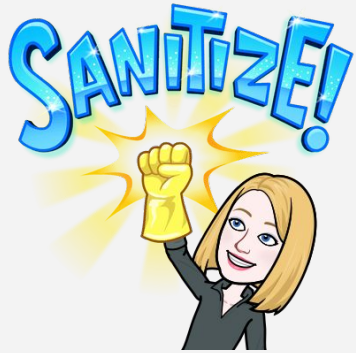
# Social and Emotional Supports



- Social-emotional support for students and staff is more important than ever.
- We will build-in opportunities to help address anxiety, fears and uncertainty.
- Counselors/social worker will be available to consult with teachers and work with students and families in need of support.
- Our goal is to have children feel a sense of positivity, safety and security.



# Preventative Practice for Cleaning



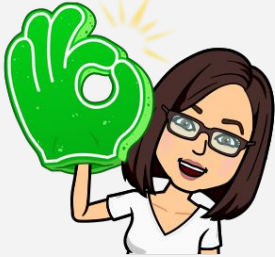
- Professional development for all staff.
- Purchase of equipment and supplies that allows for the appropriate amount of cleaning for buses, classrooms, cafeterias, restrooms and playgrounds.
- Water fountains will be turned off. Hydration stations will still be accessible.
- Frequent hand washing and hand sanitizing for staff and students.
- Additional barriers installed for office staff.
- Use of electrostatic sprayers for sanitizing.



# Digital Learning Attendance

- Attendance is **required** for both in person and at home learning days.
- Attendance will be taken by:
  - Daily logins to Google Classroom.
  - Daily teacher and student interactions such as: messaging, emails, phone calls, work completion and video chats.
  - Absences will require a phone call to the attendance line for both in person and E-learning days.
  - Truancy will be reported in accordance with the Ohio Department of Education.

## New Protocols



- Arrival/Dismissal procedures have been modified to allow for less student contact and social distancing practices.
- Student desks will be arranged to promote physical distancing in classrooms.
- Students will eat breakfast/lunch in the cafeteria or gym in small groups that are socially distanced. Grades 1-4 will eat breakfast in their classrooms.
- Students will participate in recess with their homeroom. Masks are encouraged but not required during outdoor recess. Social distancing guidelines will be followed. The play structure will not be used.



## New Protocols



- Water fountains will be turned off. Students are encouraged to bring a CLEAR water bottle with their name on it.
- Protocol signage for social distancing, hand washing, and face coverings posted throughout the building.
- Students will have PE in a designated classroom. Art, music, and library will be done in homeroom classrooms. Students will be in the lab for computers and social distancing/sanitizing will occur.
- Visitors will not be permitted in the building. Treats for holidays and birthdays are not permitted at this time.





## New Protocols



- Mask breaks will be taken during the day at the teachers' discretion. While mask breaks are occurring, students will be socially distanced and facing forward.
- There will be no latch key at this time. We will reassess as the school year progresses.
- The library will be utilized for intervention. Students will not be checking out books.
- In person school assemblies will not be conducted. Virtual alternatives are being explored.



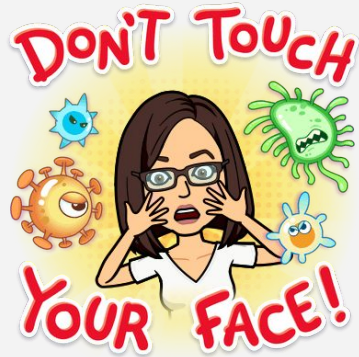
## New Protocols- 4th Grade ONLY

- 4th grade students will be carrying a backpack with them throughout the day.
- 4th grade students will remain with their homerooms and travel as one group.
- 4th grade students will be switching classes for core subjects following these health/safety guideline protocols:
  - ❖ Desks will be sprayed with a disinfectant by the classroom teachers. Students will be required to wipe off their desk surface before getting in line. (This will be taught.)
  - ❖ Students will have masks on during all transitions.
  - ❖ Students will use hand sanitizer when exiting the room and will follow all teacher directions for social distancing during transitions.





## Transportation/Dismissal



- Students will be required to sit in assigned seats based on bus stop order (2 students per seat). Siblings will sit together.
- Facial coverings are required on all busses.
- Hand sanitization will be available at the entrance of the bus.
- Cleaning and sanitizing will occur daily.
- Bus routes will be finalized Mid-August.
- Educational field trips requiring transportation will not be scheduled.
- We will be staggering dismissal and using three different exits. Students will be dismissed by bus, yellow car rider or daycare bus. **There will be no walk up blue car rider this school year.**



# Learning Options

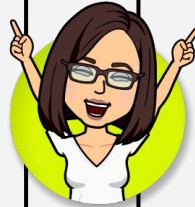
## Hybrid/Remote Model:

- Students will be on an A/B schedule.
- Group A: Last names A-L will physically attend class on Monday/Tuesday
- Group B: Last names M-Z will physically attend class on Thursday/Friday
- Wednesday is remote learning for all students (students will need access to a device.

If you choose this option, students will be placed in a homeroom class. Class lists will be posted on the doors of Vincent at 3:00 on August 18th for grades 1-4

Kindergarten class lists will be posted on August 25th at 3:00

## Virtual/E-Learning Model:

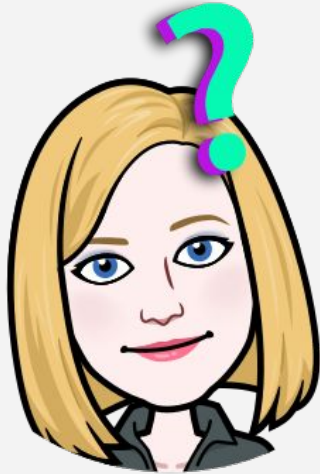
- Vincent Students will engage in the [Calvert Online Learning Platform](#)
