CLEARVIEW LOCAL SCHOOL DISTRICT
RESOLUTION OF NECESSITY
FOR THE RENEWAL OF AN EMERGENCY LEVY
(R.C. § 5705.194 - 5705.197)

The Board of Education of the Clearview Local School District, Lorain County, Ohio, met in regular session on June 8, 2015 with the following members present:

_____ moved for the adoption of the following Resolution:

WHEREAS, at an election held on November 2, 2010, the voters of the Clearview Local School District approved the renewal of an emergency tax levy (the "Existing Levy") pursuant to Sections 5705.194 through 5705.197 of the Ohio Revised Code in order to raise the amount of \$352,690 each year for a period of five (5) years for emergency purposes, at the annual rate necessary to raise that amount, commencing with a levy on the tax list and duplicate for the year 2010, the proceeds of which will be received for the last time during calendar year 2015; and

WHEREAS, the revenue that will be raised by all tax levies which the Clearview Local School District is authorized to impose, when combined with state and federal revenues, will be insufficient to provide for the emergency requirements of the School District.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Clearview Local School District, pursuant to and in accordance with Ohio Revised Code Sections 5705.194 through 5705.197, that it is necessary to renew all of the Existing Levy, which is in excess of the ten-mill limitation for the purpose of providing for the emergency requirements of the School District. The amount of money necessary to be raised for that purpose is THREE HUNDRED FIFTY TWO THOUSAND SIX HUNDRED NINETY DOLLARS AND ZERO CENTS (\$352,690.00) for each year that the renewal millage is in effect (the "Renewal Emergency Levy"). The Renewal Emergency Levy shall be in effect for ten (10) years and shall include a levy upon the 2015 tax list and duplicate, to be first distributed to the Board in calendar year 2016, if approved by the majority of the electors voting thereon.

BE IT FURTHER RESOLVED, that the question of levying the Emergency Renewal Levy shall be submitted to the electors of the Clearview Local School District at the time of the election, November 3, 2015.

BE IT FURTHER RESOLVED, that a copy of this Resolution be certified by the Treasurer of the Board of Education to the Lorain County Auditor with instructions to calculate and certify to the Board of Education of the Clearview Local School District the estimated annual levy, expressed in dollars and cents for each one hundred dollars of valuation as well as in mills for each one dollar of valuation throughout the life of the levy which will be required to produce the amount set forth in this Resolution.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
