Good morning,

Enclosed is the estimate of your district's program costs for the 2023-24 fiscal year for services to be rendered per your Primary Service Agreement and subsequent agreements.

For FY24, most of the increases in service costs are related to typical staff step increases and an increase in health insurance. ODE Gifted funding to the ESC increased which has lowered gifted estimated costs. Audiology costs increased as we hired a part-time staff person to cover the increased caseload. Parent Mentor budgeted costs are comparable to FY23 actual costs. The Pathways to Success budgeted rate did not change as the ESC is subsidizing the program which includes a Social Worker, part-time SRO, part-time Intervention Specialist.

Monthly invoicing will begin in September, so if you prefer to pay through your foundation instead of direct invoicing, please sign the attached contract and return to me by *Wednesday, August 30th, if at all possible*. I'll enter the form(s) into the CCIP and signatures/approvals will need to be provided in the CCIP by the two of you, Franco and myself. If there are any services you prefer to pay monthly please deduct them from the amount entered on the form and let me know which services we should invoice monthly.

For those of you who haven't taken the opportunity in the past to pay through the foundation, an advantage is the estimated costs of your services for the year are paid for by the last foundation payment in June.

Also enclosed are your final costs for FY22-23. If you had an over payment the credit has been applied to your FY23-24 invoice. <u>You'll receive an invoice for an amount due.</u>

Some FY23 costs have been adjusted for actual expenses. Gifted costs were slightly higher than budget based on additional supply and copy costs. Audiology costs are slightly higher for additional travel expenses. PEP Assist costs are higher based on the number of usage. In FY23 we absorbed the increase in Pathways to Success costs and Transition Coordinator costs. Occupational Therapy costs are lower as a day of service was added after the start of the 2022-23 year.
