## CLEARVIEW LOCAL SCHOOL DISTRICT RESOLUTION 2025-13

RESOLUTION (1) DECLARING THE NECESSARY OF SUBMITTING TO THE ELECTORS OF THE CLEARVIEW LOCAL SCHOOL DISTRICT THE QUESTION OF THE RENEWAL OF AN EXISTING EMERGENCY TAX LEVY AND REQUESTING CERTIFICATION OF TAX DATA FROM THE LORAIN COUNTY AUDITOR.

The Board of Education of the Clearview Local School District met in regular session on January 13, 2025, with the following members present:

## Michael Mielcarek moved for the adoption of the following Resolution:

WHEREAS, at an election on November 3, 2015, the electors of the Clearview Local School District approved the renewal of an existing emergency tax levy to raise the amount of \$352,690 each calendar year for ten (10) years, for the purpose of providing for the emergency requirements of the District, which renewal will be last placed on the tax list and duplicate in 2025 and will have its last collection in calendar year 2026;

WHEREAS, the Board of Education of the District has determined that the revenue that will be raised by all tax levies that the District is authorized to impose, when combined with state and federal revenues will be insufficient to provide (for the emergency requirements of the District; and

WHEREAS, pursuant to Sections 5705.194 through 5707.197 of the Ohio Revised Code, the Board has determined that it is necessary to renew the existing emergency tax levy in excess of the ten-mill imitation in order to raise \$352,690 annually for a period of ten (10) years, in order to (provide for the emergency requirements of the District; and

WHEREAS, in accordance with Section 5705.195 of the Ohio Revised Code, in order to submit the question of the renewal of the existing emergency tax levy to the electors in the District under Section 5705.195 of the Ohio Revised Code, this Board must first request the Lorain County Auditor certify the renewal levy, expressed in dollars for each one hundred thousand dollars of the County Auditor's appraised value as well as in mills for each one dollar of taxable value, throughout the life if the renewal levy that will be required to produce the annual amount set forth in this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Clearview Local School District, Lorain County, Ohio, that:

1. The revenue that will be raised by all tax levies which the District is authorized to impose, when combined with state and federal revenues will be insufficient to provide for

the emergency requirements of the District, and it is necessary to renew all of an existing emergency tax levy in excess of the ten-mill limitation in order to raise the amount of \$352,690 each year for a period of ten (10) years for that purpose pursuant to Sections 5705.194 through 5705.197 of the Ohio Revised Code.

- 2. Said renewal tax is to be levied upon the entire territory of the District, which is located in Lorain County.
- 3. The Board intends to submit the question of this renewal tax levy to the electors of the entire territory of the Clearview Local School District, at an election to be held on November 3, 2025.
- 4. Said levy shall be placed on the tax list and duplicate for the <u>2026</u> calendar year for collection commencing in <u>2027</u> if approved by a majority of the electors voting thereon.
- 5. The Board authorizes and directs that a copy of this Resolution be promptly certified by the Treasurer of the Board to the Lorain County Auditor with instructions to calculate and certify to the Board the annual levy expressed in dollars and cents for each one hundred thousand dollars of the County Auditor's appraised value as well as in mills for each one dollar of taxable value, throughout the life of the levy which will be required to produce the annual amount set forth in this Resolution.
- 6. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this Resolution were taken, and all deliberations of this Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public in compliance with the law.
- 7. This Resolution shall be in full force and effect from and immediately upon its adoption.
